Commissioners Reports:

Christianson:

Gave floor to Jeff Moberg Water Superintendent. Moberg advised Commission Board that he has been contacted by Roc Resources and they would like to tie into our sewer system, two options are a smaller lift station or construction of sewer lines in that area that would tie into the sewer main on 67th. Commissioners advised Moberg to have Engineers do a cost estimate to evaluate what would be more effective now. Moberg also informed Commission Board that the City has not put in water meters at the fire suppression lines and when breaks occur it causes a water loss for the City that can't be accounted for. Commissioner Christianson will have further discussions with Moberg before presenting something to the Board regarding fire suppression line meters.

- 1. Legal Pendlay Advised Commission Board that she is currently reviewing the abstracts for the property the City of Tioga has agreed to purchase and will advise Salinas when it's complete. Pendlay is also revising ETA ordinance and has completed the revisions of the contract with Moore Engineering.
- 2. Moore Engineering Kent Ritterman Update given to Commission Board on progress for the Northeast reconstruction, design plans are at 30%, will schedule a meeting next week for preliminary project layout. Ritterman advised Commission Board that they meet with staff to review new GIS mapping program and will be working on a cost estimate with trade-in of old equipment for their review. Also advised Commission Board that he has spoken with NDDOT regarding 2019 TAP project and when would be the best time to take it out for bid, Ritterman advised Commission Board that he felt October of 2020 would be better in order to have appropriate time to complete plans. Weflen advised that after speaking with the Street Superintendent one of his concerns was the size of the cement sidewalk on the TAP project which would only be 5-foot-wide and the equipment owned by

- City to clean sidewalks is 6 foot wide. Weflen asked if that change can be added to the changes already given to NDDOT TAP 2019 Grant, Salinas stated she would call and ask.
- 3. FCI Austin Rollag Update given to Commission Board on progress for the new Police station and the museum.
