Commissioners Reports:

Bugbee: Advised Commission Board of updates at the Community Center.

Christianson: Advised Commission Board that the working barge at the Waste Water Treatment Facility was

Except as expressly supplanted, modified or repealed in this supplemental Article 12 of Chapter 5, the regulations contained in said Chapter 5 remain in full force and effect. 5.1114 Penalty In addition to the suspension or revocation provisions contained herein, a violation of the provisions of this ordinance may result in the imposition of a civil fine of up to \$500.00 per day, for each and every day a violation of this ordinance may occur.
